Religious Bias and the Nigerian Experience: Who Really Betrayed Jesus Christ?

Religion is a veritable tool for national growth and development. It has contributed to the socio-political and economic development of Nigeria. But the negative influence bought by ignorant men and women is the lacuna between performance and failures. In this work we examined some themes in the bible, like who betrayed Jesus Christ, who did the serpent deceived? And some examples of religious crises in Nigeria and bring to the fall the misconception of present day religious leaders. And finally posit that, the ignorant of religious leaders and that of their followers have contributed to the problem religion has dragged us into!

INTRODUCTION

The words of Jesus Christ written in red ink in most (king James version) of the bible is correct and objective. But the bible which is a compilation of various actions of pastors or men of God is not logically correct because the people who said various things in the bible are mortals who are not perfect like their master Jesus Christ and God. Not that all what they said is illogical but there are some salient ones which are relevant to our present day. So, when discussing the various themes and subjects in the bible it is very instructive for us to apply logical reasoning in explaining every actions and events there in. For people in doubts, in the book of Exodus 32:9-14 Moses emphatically advise God not to destroy the children of Israel so that the people of Egypt will not say that because God was not able to protect them any long hence he destroyed them. Immediately, God heard Moses his prophet, and rescinded on his decisions¹. But why was its Moses an in perfect being, the one to advice God a perfect spirit² or was God trying to see if he can stand in the gap? Well, from a historical background the scripture said God was advised. So, if God was advice at the point of him being misinterpreted, men and women of God are not devoid of it. That is to say when holy men of God wrote in history³ their actions and inactions were not devoid of emotions.

This paper as a result of the theme, its interpretations will be full of emotions. Hence it is appropriate for us to put down many examples from the scriptures. Moses was the prophet of God who wrote the books of Genesis, Exodus, Leviticus, Numbers and Deuteronomy. The events in it were not done in his present, yet he did a good job by explaining what happened more than two hundred years before he was born. Yet there were lots of mistakes which were not typographic. Amongst the prophet that saw God pass by after showing its back is Moses⁴ yet there were still some errors that came from him. "The life span of mortals are three score and ten (70 years) but by the reason of strength it shall be four score" (80 years)⁵ but on a contrary the book of Genesis 6: 3 which Moses asserted that,

"And the lord said my spirit shall not always strive with man, for that he also is flesh: yet his days shall be an hundred and twenty years".⁶

But still one of the great great grandson of Adam, Methuselah lived nine hundred and sixty-nine years old before he died⁷. Even Jacob whose name was change to Israel lived one hundred and forty-seven years. So, where did the three score and ten or four scores came from? Prophets and other servant of God do make mistakes, so was one of the greatest prophet in Israel, Samuel. He was ask by God to anoint somebody in Jesses house by name David but he got there and almost did some-thing else until God told him that he judge by heart not physic⁸, if the instruction had not come, the actions could have spell doom for the young state of Israel. But who knowns if David was also a wrong choice?

Again if truly God was the one who hardened pharaoh's heart⁹ and made him for the final destruction in the red sea¹⁰, it there for follow, that it is not the later who cause more problem for the Jews but God, hence the killing of the first male born (heirs) in Egypt was on called for.

No one person on earth today without the element of religion and emotion which are the two most important reasons why people go to battle or war, if or when we go to war because of religion and emotions, who wins? Though this question may sound rhetorical, there are personalities who wish for troubles, for political and economic gains, however who wins today may loose tomorrow base on the side of negotiation. Whether from the side of strength or from the side of weakness because non of us remains a victor or a winner all the time. In our local group we could be a winner but when it leave there we are or may be a looser hence it is proper we put things right where ever we are. But what about perception? We shall deal with it when we begin to explain the theme of the work.

Did the Serpent Really Deceived Eve or Her Husband Adam?

In the book of Genesis 1:26 God says:

*"let us make man in our image, after our likeness: and let them (Adam and Eve) have dominion over every other creature God made*¹¹.

From this passage it will be deduce that God or nature gave authority to the man (Adam) which pass to his wife (Eve) before it get to the primate creatures down to other animals. For example it was the privilege God gave to Adam to name the animals which was a nexus between Adam standing as a middle personality between God and the animals. Which is very clear in the book of Genesis 2:19-20¹². As time progresses Eve was formed from the man and given to Adam as his wife which is the mother of all living¹³ but the rules of state behaviour between the state, husband and wife with their creator or God-father was tempered with, hence there was trouble. But who broke the law, was it Adam, his wife Eve or were they trying to rebel their lord? Or could it be the serpent as the people have said over the years? Well, with logical reasoning's we shall know.

The Garden of Eden was a city which looks like heaven on earth because of the natural resources deposited in it by nature¹⁴. As a result the family who leave in it were not suppose to be hungry and if they are not? Will not lead to dissatisfaction! But the reverse was the case. The couple were not hungry neither angry but in a bid to find out new things they question the authority of their creator who told them to make use of every thing in the garden but the tree of knowledge should not be touched¹⁵. Despite the evidence from the bible many a religious scholars have continue to make the mistakes that the woman was deceived by the serpent to sin against God. By eating the forbidden tree and later given to her husband who too join in the rebellious activities. But is it really true?

When God created Adam and Eve he made the man to be in charge of foreign affairs (relation between it, his state and other foreign bodies). While the woman was in charge of domestic politics. Yet the woman still need to take the final order for any decisions the woman is to embark upon. So when the serpent came to tempt the woman and later give her the fruit from the tree of knowledge to eat and later given to her husband both failed in their inter-governmental activities (to consult with each other) hence they rebel their lord. Because when the woman was taking the fruit from the devil her husband was right there. If he has not failed in his responsibilities he should have restrained his wife from talking to an outsider in his present¹⁶.

But another point I want us to consider in this work is that, the serpent did not deceived the woman neither her husband but the couple was just trying to discover new things. No where has it been said in recorded history that animals like snake gave orders or suggested to humans to carry out an assignment because the reptile are inferior to man which the bible said must take orders from man¹⁷. But man gives orders to animals like dogs to carry out functions because they are docile animals. The decision to break the law of their master was burn out of the desire to see what will happen to them if they touch the fruit of knowledge. And the decision came from their mind. For instance in the work, battlefield of the mind: winning the battle in your mind Joyce Meyer asserted that,

"Our mind is the leader or forerunner of all actions. These actions are a direct result of our thought. If we have a negative mind we have a negative life"¹⁸.

Which the book of proverb called as a man thinketh in his heart, so is he¹⁹. But went up to say that the serpent which is the devil gave the thought to them. However the people should have been allowed to take responsibility rather than heaping it on the devil which they did not set their eyes on. Could it be they (like Joyce Meyer) are referring to whenever man thinks what is not good to be the work of the devil? Well it could be, as Paul stated that,

*"For I delight in the law of God after the inward man. But he sees another law in his members, warring against the. law of his mind (which is God), and bringing him into captivity to the law of sin which is in his member"*²⁰

To put more emphases in what we have stated is that for a people to rebel there must be an element of dissatisfaction in a system. But in this case there was known. But when the master came for a meeting with his people, they were nowhere to be found. After searching for them, he called out.

"Adam where are you"^{21?}

Eve was not called but Adam, because the responsibility of governing the city was place on his shoulders. The questions have you eaten the fruit of the tree which I commanded you not to²²? Is showing the principle of fair hearing and also stipulate that God is not all knowing as the bible claim. Adam did not put the blame on the devil but his wife which he failed to cautioned²³. Further God did not ask the serpent because he knew it was not responsible for the act. But when the woman said it was the serpent fault, then God faced the serpent and caused it thus,

"Because thou has done this, thou art cursed above all cattle, and above every beast of the field;

Upon your belly shall you go and dust shall you eat all the days of your life^{"24}.

What effect was the curse because the snake was use to the dust, eat in it, move in it, and man or human's do have a good relationship with the serpent in the places like the Philippine and Indians. For the woman it stated,

"I will greatly multiply thy sorrow and thy conception, in sorrow thou shall bring forth children, and thy desire shall be to your husband and he shall rule over you"²⁵.

Again the woman was supposed to deliver in pain because the virginal is an inelastic hole which is not too wide for easy access, and from the beginning God said that the woman should be under the authority of the man so it was not when she ate the forbidden fruit that make it like that. The man's portion of the curse was that,

*"From sorrow he shall eat after he his till the ground and it shall be thorn and thistles for man*²⁶.

Yet, Noah, Abraham, Sarah, Rebecca, Jacob, Moses, Elijah and many others found favour in the sight of God. According to the bible man's quest at finding out new things was a panacea to the hidden treasures of God hence he (man and woman) was driven from the garden of Eden²⁷.

Judas Iscariot Who did He Betrayed?

The last Christian age is this era, from when Jesus Christ came from heaven, to the time when his apostles preached round the world for souls to be saved from the Armageddon that will take place in the foreseeable future. At first the testator had to give his life for the world of sin. That is, he must first be betrayed by whoever²⁸. For the redemption to be finalize. But the questions that have been on the lips of many historian over the years is who really betrayed Jesus Christ, was it Judas Iscariot? As many religious ministers, (present day ministers and their ancestors who wrote some books in the bible especially, Matthew, Mark, Luke, and John plus many others) will want us to believe. These

questions and many others, we hope to explain in this work because it is germane to the redemption picture

Jesus Christ was born in the little town of Bethlehem during the reign of Caesar Augustu. From the time he was born by virgin Mary and her husband Joseph to when he started his ministry at the age of twelve (12) he worked with his father, Joseph as a carpenter. Before and after he started his ministry in his small town to the Asia and near East he was known to all asunder because of the message he preached which was a departure from the past and as such religious clerics were amazed at his wisdom at age twelve²⁹. Which make them to always listen to his teaching, as far as asking questions. It was the fall out of this that made a Pharisee named Nicodemus, a ruler of the Jews to meet Jesus at night, because he wish to know what he must do to be born again³⁰.

For division of labour he officially chose twelve (12) disciples. While the unofficial one hundred and twenty (120) departed when the goings were tough³¹. The twelve disciples are, Simon Peter, James, Matthew, Judas Iscariot, Andrew, John, Philip, Bartholomew, Thomas, James Alphaeus, Simon Zelotes and Judas³². One of the disciples, Judas Iscariot was replaced by Mat-thias after the former committed suicide following his betrayal of his master for just thirty (30) pieces of silver by a kiss³³. But why did the historian who recorded the events lied? Or distorted history? Well let examine the story.

As stated earlier Jesus Christ was not a twins that the people (army and the Pharisees) did not recognize him nor was he absent from his people for a long time or that he and his disciples look alike. The population was not much or the Pharisees blind not to have recognize the man they have consistently ask question over years³⁴. But, for the bible to have said that that Judas Iscariot, conceived with the Jews to be betrayed his master is not logical. Because both Parties were not in a disagreement which history rest upon. The only disagreement they had is recorded in the books of John 12:1-6, Luke 22:3, Mark 14:10 and Matthew 26:14³⁵. Logically it is not the reason the bible said Judas Iscariot betrayed Jesus Christ. Because Matthew, Mark and John stated that Mary came with the alabaster box full of ointment poured it on Jesus feet because the material is costly they grumbled that it should have been sold and given to the poor. But Jesus said the actions of the woman is justifiable because it is for his burial and will be in remembrance of the woman. But his disciples always think about the poor what about him.³⁶?

The following event was when Judas Iscariot went to conspired with the enemies against his master which the book of John did not record. But that of Luke 22:3 state that it was the devil who entered into Judas Iscariot for him to conspired with the enemies against his master which the book of John 12:6 confirmed that because he was a thief he was making a case for Mary with the alabaster box full of ointment to be sold and the money

given to the poor but it was not established whether he will steal the money and that there was no other place mention to show if he has stolen before.

Meanwhile the bible state that God sent his only begotten son to die for the sins of the world,³⁷ and if so, did he need to be betrayed by one Judas Iscariot? To put the events in a historical context Judas Iscariot did not betraved Jesus Christ. The books of Matthew 26:48, Mark 14:45, Luke 22:47 and John 18:1-12 gave different account of the event which led to the arrest of Jesus Christ³⁸. In John's account it was not a kiss but showed the Pharisee's officers where Jesus Christ normally relaxed with his disciples and when they got there Jesus by himself told the army that he was Jesus of Nazareth when they ask. The other synoptic gospel stated that it was with a kiss. One question we must not fail to answer is who among the disciples were there when the event look place? Mark 14:33 state that Peter, James and John were with Jesus Christ when Judas Iscariot came with the army³⁹. Matthew wrote about the betrayer yet he was not there even Mark and Physician Luke who was not Jesus disciples (Physically present with Jesus) wrote about what he did not see. Nevertheless that of John is accepted because he was present when the event took place. Even at that, Jesus Christ categorically state at different times in the four synoptic gospel (Matthew, Mark, Luke and John), that it was the "Will" of God that he was to be betrayed by a mere mortal which was the cup prepared for him by his father to drink⁴⁰. or else.

*"Who is he that say's a thing and it comes to pass when God has not said so"*⁴¹

What is also possible in this matter is that every thing that Jesus said was not written down by himself but his disciples who were mortals and not devoid of mistakes. In other words, they were not perfect human being. Moreso, that Jesus Christ did not mentioned the name of Judas Iscariot as one who will or must betray him apart from he, consistently saying one of you will betray me⁴².

Are We All Going To Die?

The death of a loved one is an avenue for emotional outburst. Like what happened when Jesus healed the windows son⁴³. Only son it was! The presences of mourners did not change anything until the changer came-Jesus Christ. However before then, the woman was reminded by the mourners who were with her that she should take so-lace in the fact that, God gives and he takes, and that we all must pay the supreme price which is death even though not in one day. But when God determines for a better place, however if we do well. But is it really true that God gives and he takes? Are we all going to die? Under what condition(s)?

The books of 1Corinthian 15:47-58 and that of 1 Thessalonians 4: 14-17, showed us a mystery which many of us are ignorant of. In the first book quoted it revealed that, we shall not all die, but we shall all be changed in a moment in the twinkling of an eye at the last trumpet⁴⁴. The people alive will be caught up with the people who will be awakened from death to meet their lord, that is if they do well while they were on earth. One point that is similar to the two books quoted from the bible is that we all shall not die! But why have religious scholars continuously preached that we all shall die? Could it be that it is a false conclusion in the two books read or its theological experience? Well time shall tell.

The bible as a book of history is clear on the issue of creation, man and his works, future and that of the world society⁴⁵. But what is not clear is the behaviour of mortal as it relate to the past, present and the future as to how they make use of their intellect and emotions. From the bible point of view and the stride made so far in the field of science it is clear that God and man gives life from the angle of text tube⁴⁶. But the believe that God takes is illogical because it is not the wish of nature to give and take when the person in question is still young to serve its people or better still when its form and physiology is still active and functional. When people die, especially those who have served their community, or over work their organs, it is not God who took but, the individuals. The point being made here is that a deceased person could be forty years before he or she passed out yet its organs and physical make up have worked hundred years and more. In an other development a deceased person could passed out at age thirty without fully using its potentials but failed to work with reason or its was clamped down by illness. Yet nature is not still responsible for its death. For nature to be responsible for an act it must first defile logical reasoning else it sentiment. When people die as a result of sudden death it is not nature but the failure of the people to constantly go on medical examination because of the modern age of toxicology, sickness, poverty, famine, hunger, leadership failures and the stress attach to the jet age.

The issue of nemesis is not still left out here because what you sow you reap. But to which extent? Because many persons have sowed evil plant and reap good plant or have they buy nature? Who can really buy nature is it not God who said he is giving them a long rope to change but if they fail he shall cut it off⁴⁷? But because the rope God gave is too long the Chinese and other nationals who wish to fight large scale corruption have consistently execute robbers who drag their society back ward by way of administrative theft.

If it is really true and logical that we all shall die before the coming of Jesus Christ then re-incantation is possible because all those who will see him coming from the sky might have died and re-incarnated. But if not all of us will not die but see him coming to take us home to a place where each believer has a room for itself⁴⁸. We are not saying that God is not capable of creating more souls, spirits and bodies to see him comes but we are agreeing to the conclusions made by the books of Corinthians and Thessalonians that we all shall not be asleep when God comes⁴⁹. But that we should watch and be sober so that when he comes we shall go with him or peradventure if we die before he comes in our presences we shall be awaken by the shout of his trumpet when the people who died in Christ might wake up first⁵⁰.

Howbeit we shall consider two more text before we conclude this debates. In the book of Ecclesiastes 3:1-8, it state that for every living being under the sun there is a time to be born and a time to die⁵¹. From this statement every being comes to the world on a particular day and also depart on a particular time. The work of A.O Imogie, Death and Dying Education for Healthy living, is not contrary to the aforementioned. As she stated that every soul born to this earth shall one day depart from it⁵².

Therefore, if all humans born to the earth shall die before Jesus Christ comes, then there is reincarnation of souls who will be on earth to receive their lord and saviour. But if we all are not going to die before Jesus comes then, it therefore means that the believe that we all shall die to pay the supreme prize is illogical and not sound. The believe that we all are going to die have it merits though, (to console the deceased relatives) but over time it has been allowed to metamorphosed into a monster of lies where it has been difficult to apprehend substance!

Can Nigeria Break Away from the Influence of Religion?

Perception is built on history. Our actions and inactions are built on it. To the Mr. know it all what we have stated from the beginning of this work is non-sense, however to the receptive mind it is not, hence we employ every sane mortals to be receptive to new ideas especially if it does not defile the principle of logical reasoning's. The church from the garden of Eden in Africa, to the near East down to Africa again before going to Rome has been affected by a long historical culture of these peoples. For example incent burnings was not among the new testament disciples of Jesus Christ but it is with Nigeria and Catholic Churches who started the Roma empire.

Similarly the interrelations of influence of religion and man (Nigerian) did not start today, however it date to the history of man. The interpretation is the miracle or link between an emotional and a rational mind, that is not to say that the intelligent have no emotions in their characters. But not ignorantly exhibited. History of Nigeria and the world will not be complete if religious manifestations are not talked about. The amalgamation of Nigeria nations into British project is not only economical and religious under tune. The Usuma dam Fodio crisis of 1804 that brought the Fulani's to lam light in Nigeria is not an exception. However we shall discuss two case studies to further put more light on our thoughts. These case studies are the Boko Haram crisis and the proliferations of Pentecostal Churches.

Intra-Religious Crisis among Christians 1980-2016

Intre-religious crises did not start today but a long time ago. The holy crusade of the 11th, 12th and 13th century between Islam and Christianity is a testimony to that fact⁵³. Intra-religious conflict is not either. The social -political and economic religious crises have been prevalent among the Christian folks in Nigeria since its independence in 1960. These crises is largely within the leadership of the indigenous ministries. The first few Churches created by indigenous people are, Christ Apostolic Church in 1914 by JA. Bababola, church of God Mission between 1970-1975 by Benson Andrew Idahosa. Deeper life bible church in 1976 by William F Kumuyi, living faith church (Aka winner's chapel) in 1981 by David Oyedepo⁵⁴. The rest that were created or established before 2000 and after are too numerous to mention!

From 2002 till date over one thousand churches have been establish all over Nigeria. As a matter of fact it is difficult for you to pass the major streets in Benin without seeing a church sign board. Between two and three. From few churches in Nigeria second republic to thousand of ministries after its fourth republics. The reasons for this are break away, the boom in the business of church management, unemployment and the illiteracy among Nigerian populace. For example the founders of church of God mission, Benson Andrew Idahosa before he established its own was a full member of Assembles of God mission⁵⁵. With the reason that he was called out to form his own. He has not started doing his major exploit when his two foot solders, Pastor Ayo Oritsejafor and Reverend Felix Omobude went to established theirs, word of life bible church in 1987 and New covenant bible church in 1988 respectively⁵⁶. Churches like Deeper life bible church, Assemblies of God church, flock of Christ, Ministries of perfection, New life Evangelistic ministries, Christ chosen church of God ministries, venture Omo ministries, Goshen Baptist church and a host of others have experienced break away of vibrant ministers who went to established theirs. Assemblies of God church and church of God mission have experienced violent break up. This break away was finally settled in court.

The violent shake up of leadership that happen in church of God mission was not without casualties also with that of Assemblies of God church. For church of God mission it was Idahosa and its loyalist on one side while Ekubu, Itiveh and Flkinjobi under the direction of Francis Ogiamien⁵⁷. The crisis finally led to the death of some prominent members of Idahosa's church and the lawyer who was in charge of the case. But is it a reasonable thing to fight for God or gods with arms? Because from the book of II Corinthian 10:4-5 we were told that, "the weapons of our war-fare are not carnal but mighty through God to the fulling down of strong holds and casting down imaginations, and every high thing that exalted itself against the knowledge of God, and bringing into captivity every thought to the obedience of Christ^{*58}.

In other words religious battles are not with physical materials but a spiritual one. But why then do Christians or believers fight with physical material? Or have they lost faith in their lord and saviour, Jesus Christ ability to fight their battles for them? Other wise we are force to conclude that, either the believers are ignorant of the God they serve or the God is not omini-present and all powerful as we are told to believe by our pastors and the bible.

Our interest in this matter is not whether we have over two thousand church names in Nigeria but the quality in their service to the nation. Because it is the lack of it that have made some fraudsters to parade themselves as leaders without leadership,

Can They Really Force Us Against Our Religious Wishes?

Nigeria nations from its pre-colonial era have not had a turbulent experience as it does of late because of Boko Haram crisis and Muslim fundamentalist. Kano state because of its historical development had plays host to different kinds of Islamic scholars, especially from north Africa and the neighboring Cameroon and Chad Republic. A few of these especially in colonial and post-colonial periods introduced Kano to fundamentalist religion activities which led to the development of several Islamic sects in the city. From where it spread to other parts of northern Nigeria⁵⁹. The action and inactions of the fundamentalists are for their interest not their gods as they claimed. For instance one of the five pillars of Islam are for Moslems to always engage in good deeds. But Muslim fundamentalist have always turned the Koran upside down to favour their interest. As we have seen the major sects in Nigeria are involve in one form of crisis to the other, in the last four decade of Nigeria independence. For example in 2009 the Boko Haram sect was involve in violent clash between it and security operatives in the country which led to the death of over 700 sect members⁶⁰.

What they constantly preached is that Nigeria must be an Islamic state so that things can developed faster as it is in other Islamic state of Libya, Yemen, Saudi Arabi, and many other Islamic states. But does it mean the reference point have no challenges? Or better still why are they forcing us against our wish? In a publication made by Tell in 2009 state that the entire sect in Nigeria are against each other by claiming guineaty a situation which stipulate that they are misinterpreting their koran⁶¹. From the above it shows that, either we are illiterate of what we profess or our God or

gods are not really powerful to what we made them to be! Or better still we are the one controlling our gods with our action and inactions. For instance in 1804 Usuma Danfodio and his followers change the history of northern Nigeria by up turning the status quo there by bringing the Fulani's who had no defined territory in Nigeria to the main stream by the instrument of religion. Soon after he conquered the Hausa land the corruption which was a major reason why he took over power was now a norm. But one point which is clear is that our gods have failed to enter into the man he created from the beginning so that they can always be useful for gods works.

Again the fundamentalists (terrorist) have said they do not need western education, because it is with it the western world stereotype the activities of developing countries yet some of the things they make use of are from the West. Like communication instruments or are they saving western culture or inter-changing western culture for western education? Nevertheless the activities of men and women are not stereotype by religion or education alone, the interpretation of data and the ignorance of an individual at a particular time when the person in question need to take a precise decision. So the religious crisis we have had over the years in Nigeria is as a result of ignorant exhibition of emotion in the highest order and the failure to listen to the voice of reason. Other wise why should myself as an example be fighting for my god (s) in an uncivilized manners when I believe that the later is all powerful and all knowing?

The training we have gotten in our schools and ways we have received the information have made us believe that the questions of life can only be answered from our disciplined mindset. On the contrary it is not because the hand can not perform the roles of legs, or eves, neither the anus can replace the reproductive organs of mammals. All the members of our bodies are unique in their own right. So the question of maladministration and leadership failures is not for only religion to answer alone. Other wise the states of the world who have gotten it right would have not because religion is not in their front burner like the United states of America, Britain, France, Germany, Japan, China, Singer-pore, Israel, Russia and many others too numerous to mention. We have never said is not logical to fight for the emaciation of Nigeria with arms, but it should be directed at the appropriate quarters not the vulnerable in society.

What we have stated is that the bible and the Koran is not a perfect or complete document because the religious historians who put them together were mortals who were not perfect themselves. For instance prophet Moses and his colleague king David misquoted themselves several times when they said that the full age of a man before he or she dies is 70 years but by reason of strength 80 years and in another place 120 years, when we have seen many of our neighbors lived beyond 100 and 120 years. Religious leaders because of the ignorant of their followers and sometime themselves hide under the guise to perpetrate evil which are inimical to our society. One truth historians wish to be told is how was it possible for a virgin to conceive and give birth as a virgin, how did the child came out without oppression?
